This letter serves to give permission for my/our child to participate in the activity/trip/camp. I/We acknowledge that my/our child is expected to abide by RAS school rules and always conform to RAS teachers'/staffs' instructions to ensure a safe activity/trip/camp both within and beyond the school vicinity.

1. I/We have read all of the information contained in this letter in relation to the activity/trip/camp (including any attached material hereto). 2. In the event of an accident or illness, I/we authorize RAS staff to obtain or administer any medical assistance or treatment that my/our child may reasonably require at RAS best effort, including contacting my/our child's doctor.

3. I/We shall be personally responsible for all relevant costs incurred by RAS in obtaining such medical assistance or treatment (including any transportation costs) and undertake to reimburse RAS the full amount of the involved costs.

4. I/We have provided RAS with all pertinent information concerning my/our child's fitness. Furthermore, I/We affirm and confirm that my/our child's fitness is suitable and acceptable for participation in the activity/trip/camp. For the purpose of the aforementioned, "fitness" shall mean medical, physical, and mental being in a fit and proper condition.

5. I/We also comprehend, acknowledge, and consent to the fact that RAS reserves the right, at any point, to either accept or decline my/our child's participation whenever RAS deems necessary or if, according to RAS's judgment, my/our child is causing an undue disturbance or posing a danger to themselves, other students, participants, or RAS.

6. I/We give consent to RAS to store and process the Personal Data provided in this letter for the purpose as described in this letter and to disclose the Personal Data to the relevant governmental authorities or third parties where required by law or for legal purposes. For avoidance of doubt, Personal Data includes all data defined in the Personal Data Protection Act 2010 including all data I/We have disclosed to RAS in this letter.

7. I/We recognize and comprehend that, despite RAS's commitment to taking every reasonable and practical precaution, participation in the activity/trip/camp may inherently entail certain unavoidable risks. These elements of risk are integral to the sense of adventure and enjoyment that students experience, and RAS regards them as crucial to the social development of students.

8. I/We hereby acknowledge and agree that RAS, along with its elected officials, officers, Directors, employees, agents, volunteers, and representatives, cannot assume responsibility or liability for force majeure events beyond their control. Such events include but are not limited to Acts of God, war, armed hostilities, earthquakes, floods, fires, strikes, riots, civil commotions, government restrictions, embargoes, attacks on IT Systems (such as virus attacks and hacker attacks), network or system interruptions or breakdowns, internet or communications failures, epidemics, pandemics, or disease outbreaks.

9. I/We acknowledge and willingly accept all the inherent risks associated with my/our child's participation in the activity/trip/camp, including the potential for personal injury, loss of life, property damage, or loss, whether these risks are anticipated or unanticipated. I/We hereby acknowledge and accept that RAS, including its elected officials, officers, Directors, employees, agents, volunteers, and representatives, will not assume a parental role for my/our child.

10. In consideration of my/our child being granted the opportunity to voluntarily participate in the activity/trip/camp, understanding its inherent risks and hazards, I/We hereby release, waive, and forever discharge any and all liabilities, claims, and demands, whether in law or in equity, of whatever kind or nature, against RAS, including its elected officials, officers, employees, Directors, agents, volunteers, and representatives.

11. I/We further commit to fully indemnify and hold harmless RAS, along with its Directors, employees, agents, volunteers, and representatives, against any actions, deeds, matters, or omissions carried out by RAS in accordance with any directions or instructions provided by me/us to RAS. This indemnification shall be in effect at all times and fully protect RAS from any associated liabilities or claims.

12. I/We acknowledge that for the emotional well being of my/our child and/or for their roommates, only RAS has the right to change their dorm allocations after the final applications have been submitted. All dorm allocation requests need to be submitted before the closer of applications (only applicable to Boarding students).

13. I/We understand and agree that RAS shall make the final decision for my/our child's placement in a class deemed suitable for both their age and English levels based on RAS testing procedures.

14. Refund Policy: In the event of a denial by Malaysian authorities, due to circumstances beyond the control of the parent/student, a full refund of 100% will be processed within thirty (30) days. To initiate the refund, official proof regarding the border issue must be documented and provided to the Camp Director.

15. I/We acknowledge that the responsibility for student's property rests primarily with the students attending the camp, rather than with RAS. While the school and its staff will make every reasonable effort to help locate lost items, it is important to emphasize that the ultimate responsibility for safeguarding their belongings during the camp lies with the students themselves.

16. I/We understand that all Intellectual property including all current and future copyright including but not limited to Camp format, photos, images, videos; trademarks; property rights; title and interest with respect to the Camp, the participants and the Camp activities (whether or not registered) shall be owned and remain the sole property of RAS and RAS shall have the liberty to use such Intellectual Property worldwide in any media. I/We hereby waive and shall not assert any rights I/We may have in any of RAS's materials aforementioned.

17. I/We understand that all day students must have a parent or guardian responsible for their care after school camp hours. RAS shall not be held liable for the supervision, welfare, or safety of day students outside of official camp hours.

This Consent Form including all clauses stated above shall be construed in accordance with the laws of Malaysia. In the event of a conflict between the English and Foreign language versions, the English version of this Consent Form shall prevail.

## APPENDIX 1

### **RISKS:**

Possible risks or injuries included in the activity/trip/camp may include but not limited to:

- (a) Risk of injury inherent in playing any type of sports or recreational activities;
- (b) Exposure to outdoors, nature, weather, Acts of God, sea life, insects/animal or plant life;
- (c) Inexperience or unfamiliarity with the activity or its requirements;
- (d) Unfamiliarity with location or facility;
- (e) Faulty equipment/gear or inadequate instruction;
- (f) Complications or reactions from weather conditions or outside environment or nature;
- (g) Inadequate or unavailable healthcare facilities or assistance;
- (h) Other accidents, loss of life, illnesses, allergic reactions (food, plants, insects etc), negligence and/or mistake.

### **PRECAUTIONS:**

Recommended precautions include but are not limited to:

- (a) Check local weather before departure and be familiar with the activities involved.
- (b) Bring appropriate clothing, footwear, supplies, protective gear (sports-related, sunglasses, sunscreen, hat, etc) suitable for outdoor or recreational activities, standing/walking etc.
